

Lumenbrite T-shirt Contest

Lumenbrite Training is hosting a t-shirt design contest. The contest's rules are pretty simple: Create a t-shirt design that has a theme related to the Web, Print or Video industry. Submit your entry and first place will walk away with a brand new Adobe CS5 Premium Suite of their choice.

Creating your Entry

We've tried to make it as easy as possible for you to create your own entry. Photoshop, Fireworks and Illustrator templates have been provided for you.

Please keep the size of the entry the same as specified in the template, but feel free to modify everything else such as the background color and so on.

Some Other Guidelines

There are a handful of things you need to keep in mind:

1. Entries must not contain controversial (offensive, political, religious, etc.) content.
2. Please make sure what you are submitting is your own creation.
3. Submit the final PDF output as your entry. The contest winner must supply original files.

The last day for submitting your entry is July 15, 2010.

Submitting your Entry

To submit your entry, send your artwork to support@lumenbrite.com. All entries will be reviewed and posted on the Lumenbrite Forum under the Lumenbrite Contest Discussion. If you are submitting multiple entries, please send a separate email and attachment for each entry. Do not send multiple entries in a single email.

After you have submitted your entry, be sure to make sure that it appears in the Lumenbrite Contest Discussion within 24-48 hours of you having submitted your entry.

1. HOW TO ENTER:

Entrant must submit the completed entry of a piece of artwork, to be used on Lumenbrite Training merchandise. The Work must be in PDF format but may originate in any medium. ENTRIES MUST BE RECEIVED BY 11:59:59 PM (CST) ON JULY 15, 2010. No illegible, incomplete, forged or altered entries will be accepted. Entrants may enter as many Works as they like. Do not submit original file of the work, entries will not be returned. You should retain and store the original file on your own. Contest winner must supply the original file.

(a) The Work

- (i) May not have been made commercially available, won any other prize/award, or previously submitted to any other contest;
- (ii) Must be the exclusive original work of the entrant and made for the Contest;
- (iii) Must be in keeping with the Sponsors' image;
- (iv) May not be inappropriate, offensive, libelous or defamatory, pornographic, sexually explicit, unlawful or plagiarized, as determined by the Sponsors in their sole discretion;

- (ii) Except as expressly required in these Official Rules, entrant may not use the Sponsor Marks in any manner whatsoever in connection with the Work or otherwise without the relevant Sponsor's express prior written approval;
- (iii) During the Promotion Period, and for a period of one year thereafter, eligible Works may be posted at the Contest Site or otherwise displayed in selections made by Sponsor and in any form and media on or off the Lumenbrite Training site in connection with promotion of the Contest and/or Sponsor's products;
- (iv) During the ten (10) year period immediately following the Promotion Period, the Sponsors may (but will not be obligated to) display prize winning Works in any form and media in connection with the promotion of their respective businesses;
